

Advancing Health Equity: A Multi-Year, National Learning Collaborative

The Institute for Medicaid Innovation (IMI), <u>University of Chicago</u>, <u>Center for Health Care Strategies</u>, and <u>The Justice Collective</u> are partners in a multi-year national initiative, "Advancing Health Equity (AHE): Leading Care, Payment & Systems Transformation" funded by the Robert Wood Johnson Foundation.

The AHE Learning Collaborative identifies best practices, implements innovative initiatives, and supports policy recommendations for integrating payment and health care delivery reforms that seek to eliminate health care disparities and achieve equity.

Guided by a Comprehensive Roadmap

AHE is guided by its comprehensive

AHE Roadmap to Advance Health Equity,
that integrates the creation of a <u>culture of equity</u> with the technical steps required for organizations to: <u>identify inequities</u>; determine the <u>root causes of those inequities</u>; and <u>design</u> and <u>implement care delivery interventions and payment models to support and sustain them.</u>

Backed by extensive research and years of first-hand, practical experience, the Roadmap to Advance Health Equity is designed to aid organizations in the development of initiatives that are tailored to their specific populations and address inequities based on their available resources. It provides a critical framework for organizations to implement equity-focused quality improvement programs simultaneously or in conjunction with other efforts.



Teams Drive Reforms

Teams composed of representatives from state Medicaid agencies, Medicaid health plans, health care delivery organizations, and community partners work together to design health care delivery reforms supported by tailored payment models to reduce health disparities. Driving the work is a commitment to cultures of equity and addressing social drivers of health to generate sustainable

practices and policy recommendations for national dissemination.

In 2019, through a competitive, national application process, <u>seven</u> <u>state teams</u> were selected and began the first iteration of the learning collaborative. In just one example, the Illinois state team seeks to align resources and programming to provide housing and housing tenancy support for persons with complex health needs who are unhoused. One outcome saw the County Care Health plan investing \$5 million in tenancy, support, rent and associated housing costs for 67 members.



In 2023, <u>five additional teams</u> joined the next iteration of the collaborative. More information and detailed team profiles can be found on the <u>AHE Learning Collaborative page</u>.

Technical Assistance to Ensure Success

AHE offers technical assistance and capacity building services to the learning collaborative teams to implement the roadmap and aid in the design and implementation of integrated payment and health care delivery reform interventions. To achieve their health equity goals, the learning collaborative helps teams to align their resources and strategies while engaging Medicaid members and community partners. Teams are encouraged to design and implement payment reforms that support and create incentives for equity-focused health care delivery.

Supported by a National Team of Experts

<u>The National Advisory and Policy Development Committee (NAC)</u> is a group of national experts that supports AHE collaborative teams on the main tenants of the roadmap.
